RSB is a School open to the public to provide training of individuals wishing to become (Certified Nursing Assistants). The course is set for 90-clock hours, which consist of: classroom study, lab and hands on clinical. Class hours are flexible. Normal hours are 7 AM to 3 PM. Evening Classes would be expected to run about 4 hours a day. If classes are 7 ½ hours a day then it would take 12 days to complete the 90 hours of instruction. Classes are normally Monday – Friday.

RSB's main classroom is 1000 South Caraway, Suite 210, Jonesboro; AR. RSB holds classes in Long Term Care Facilities where possible. Clinicals must be preformed in a Long Term Care Facility to complete the course. RSB is approved by the Office of Long Term Care and is licensed by the Office of Private Career for Arkansas, and monitored by both. After the student has completed the course there is a certification test in order to become a Certified Nursing Assistant (Aid) and be listed on the States Registry. The test will be administered in a Nursing Home setting, by Prometric.

For enrollment in RSB Nursing Assistant Training Program, the student must be 18 years of age unless we have a facility at the time which will allow the 16 to 18 age bracket to perform the Clinical Portion, have a current Drivers License or ID card, and able to pass a criminal background check. Facilities minimum age requirements may vary. Most have an 18 year old minimum because of insurance coverage. OLTC allows certification at 16. After school help may be to your advantage and a lift to your residences.

Self-pay and Sponsorship. Examples of Sponsors we have seen, are Hospital, Rehab Facilities, Long Term Care Facility (Nursing Home), DWS TEA Program, Arkansas Rehabilitation Services, Clubs, etc.

Payment or arrangements with the Sponsor for payment of tuition would have to be made by the start of the first day of class.

RSB's Tuition is \$480. The state certification test is \$85 or a Letter of intent to Hire. A TB Skin Test prior to Clinicals is required. RSB furnishes Textbooks used in the class.

Books are available for purchase if the student would like.

The following will be needed as a minimum.

1. Adequate space to accommodate up to (24) students at a time for the purpose of classroom, lab and clinical skills instructions. In the case of more than 12 the Clinical days may be extended as there is a 12 student limit per Nurse per OLTC.
2. All equipment and supplies needed for simulating actual resident care. Some examples would be but not limited to, are: A working Hospital bed and linens, lavatory/sink with soap and hand towels, Wheelchair, Blood pressure cuff, Stethoscope, Thermometer, Bedside and Over the bed tables, Call light cord, Bedpans, patient bathing supplies, etc., which are used by the facility.
3. Access to break room, restrooms, etc. Knowledge of your policies for such things as smoking, etc.
